The Installment Schedule calculations for Due Dates & Amounts Due are based on the following: Effective Date of 1/1/24 & Premium Amount of \$1200.00 NB = New Business RN = Renewal Business

Timing of Billing Invoice Generation & Recurring Draft Collections

- A Billing Invoice (paper bill) is generated 22 days prior to Due Date
- Recurring Draft is created 15 days prior to Due Date (Except in the state of CO, which is 25 days)

Recurring Electronic Payment Plans

- The customer can choose their draft date (1st through the 28th)
- Depending on each state's Renewal Timing, the number of installments may vary as the current Billing Cycle will complete prior to Renewal Offer
- Recurring Payment Plans Due Dates will be based on the draft date chosen
- Renewal Down Payment will draft the Renewal payment on/after the Effective Date based on the draft date chosen
- If the draft date lands on a weekend/holiday, the payment will occur on the next business day
- There may be an initial delay of up to a month, depending on the draft date chosen to allow for customer notification of the Installment Schedule

New Business

- A Down Payment is required (reference Down Payment Structure below) *Exception: 'Bill the Down' is available for Mortgagee/Lienholder billed policies

Payment Plan Availability

- The availability of payment plans vary based on state and premium amounts

Installment Fees

- Each Installment may be subject to an installment fee (except the Down Payment for New & Renewal business)
- Does not apply to Full Pay Plans

Rounding Differences

- Any rounding differences will occur at the beginning of the Payment Schedule

Additional or Return Premium Policy Changes

- Additional Premium will be divided equally among the remaining installments, if applicable
- Return Premium will reduce or skip future installments until the entire credit amount is applied

| Bi-Monthly Pay Plan | 30% | 5 | MI = Down Payment equally divided (REC only) |
| Monthly Electronic Pay Plan | 25% | 8-10 (varies) | AZ= 20%, CO= 8.22%, RI= 15% MI = Down Payment equally divided (REC & RES) |
